There will be no pre-sale show however, the sale is open to

1. Senior Ewes
2. Yearling Ewes
3. Ewe Lambs
4. Senior Rams
5. Yearling Rams
6. Lamb Rams

All sheep will be sold through the ring.

FEMALES WILL BE SOLD WITH A MINIMUM OF 5 PER PEN  
NO VENDOR MAY BRING MORE THAN 10 RAMS TO ANY ONE SALE

### **ENTRY FEES**

**FEMALES:** £1.00 + VAT (£1.20) per head

(for the first 50 ewes entered, there after no further charge)

**RAMS:** £10 + VAT (£12) per head

*Please note there is a limit of 10 rams per vendor*

Late entries will be placed at the end of the sale.

No sheep will be sold if the vendor is not a Society Member.

**Scrapie Genotyping** is voluntary.

**SCAB**- it is recommended that all sheep are treated for scab.

## **SPECIAL REGULATIONS** **& CONDITIONS OF ENTRY**

1. The sale will be held subject to the Rules and Regulations of the Easy Care Sheep Society, the Conditions of Sale as recommended by the LAA and the Auctioneers Standard Conditions of Sale.
2. ALL SHEEP OFFERED FOR SALE MUST BE THE PROPERTY OF A CURRENT MEMBER OF THE SOCIETY AND CONFORM TO EASY CARE TYPE.  
NO WOOL - NO EVIDENCE OF SHEARING - NO HORNS
3. ALL SHEEP MUST HAVE EASY CARE PRINTED ON THE MANAGEMENT PART OF THE TAG. Your Tag Manufacturer can arrange this. If the sheep are not tagged you will be provided on site with tags and will be charged 20p per tag and you will have to tag the sheep yourself.
4. Entry is open to **MAEDI-VISNA and non MAEDI-VISNA** flocks.  
All relevant documentation must accompany all sheep.
5. All entries must be made on the official entry forms (enclosed) and must be completed in all respects. Entries must be accompanied by the **ENTRY FEE**.  
Entries will not be accepted if the relevant fees and certificates are omitted.

### **ENTRY FEES**

**FEMALES:** £1.00 + VAT (£1.20) per head

(for the first 50 ewes entered, there after no further charge)

**RAMS:** £10 + VAT (£12)

***Please note there is a limit of 10 rams per vendor***

6. Substitutes are allowed. Details of any substitutes **must** be lodged with the Auctioneers ONE WEEK prior to the sale.
7. All sheep are warranted by vendor as correct in mouth and udder at the time of sale.
8. Vendors are responsible for taking their sheep to the sale ring and returning them to the pens after being offered for sale.
9. All sheep must be delivered to the sale premises on either

**THURSDAY 4th OCTOBER - 2.00pm to 6.00pm**

**FRIDAY 5th OCTOBER - 7.00am to 9.00am**

10. Limited straw for bedding will be provided but vendors must provide their own feed stuffs/buckets etc.
11. All rams will be sold in guineas with a commission rate of 5%. All females will be sold in £'s with a commission of 5%. Commission will be split between auctioneers and the society.
12. All transactions either by auction or by private treaty following the sale must be passed through the Auctioneer's sale office.
13. Vendors shall have the right to place a reserve price on any, or all of their sheep. This must be notified to the Auctioneers in writing preferably before commencement of the sale, and will be treated as a reserve and not a guide. An upset price of 200gns will apply to all Rams and 150gns for all Ram lambs.
