1. The sale will be subject to the Rules and Regulations of the Easy Care Sheep Society, the Conditions of Sale as recommended by the LAA and Auctioneers Standard Conditions of Sale
2. All sheep offered for sale must be the property of a current member of the society and conform to easy care type.
3. No wool and no evidence of shearing
4. No horns
5. All sheep must have easy case printed on the management part of the tag. Your tag manufacturer can arrange this.
6. Entries must be made on the official entry form [attached] and must be completed in full.
7. Substitutes are allowed. Please ensure details of the substitute are lodged with the Auctioneers one week prior to the sale.
8. All sheep are warranted by the vendor as correct in the mouth and udder at the time of sale.
9. Rams will be sold in guineas.
10. All females will be sold in £'s.
11. All transactions, either by auction or by private treaty following the sale must be passed through the Auctioneer's Sale Office.
12. All stock will be sold through the ring.
13. Lot size for females is a minimum of five.
14. Please sort out your sheep into identifiable groups so the market staff can assist you in selling them.
